

# Bonus policy & Regulations

The Policy presented in this document states the rules and regulations presented to **NET24 Sp. z o.o., NIP: 525-286-49-49, Smulikowskiego 6/8 street, 00-349 Warsaw, Poland** by **Warsaw University of Business (WWSB), NIP:8251884503, Juliana Smulikowskiego 6/8 street, Warsaw, Poland** for receiving an **additional admission bonus and the discount for tuition fee in the first year of studies** for students that have been newly admitted to WWSB.

## 1. Eligibility

An agency eligible to receive an additional admission bonus and the discount for the first year of studies for a student admitted in WWSB must:

- Have a signed contract with Warsaw University of Business
- Be registered on NET24Apply platform
- Send the candidate through 'Admission' section on NET24Apply platform

Students recruitment agencies that have no contract with WWSB as well as the agencies that will send the candidate in other way than through NET24Apply platform, will not be eligible to receive the additional admission bonus.

Agencies, that are not having a contract signed with WWSB and would like to collaborate are asked to contact the following e-mail address: [kacper.cheda@wwsb.edu.pl](mailto:kacper.cheda@wwsb.edu.pl) for discussing potential partnership.

This Program is void in all areas where prohibited by state, municipal or federal law.

## 2. Terms & Conditions

Apart from eligibility mentioned in point 1., the additional bonus is being granted under the following conditions:

Conditions:

- All the participants are obliged to read the 'Bonus policy & Regulations' of the **additional admission bonus and the discount for the first years of studies** for each student admitted to **Warsaw University of Business**

- The student has to be registered for admission through NET24Apply platform with complete set of data required by the system and WWSB admission office (personal data, as well as the scans of the documents required for admission)
- The additional admission bonus can be granted only for newly registered students that have not been applying or registered in NET24Apply or internal admission process of WWSB before
- The student has to be registered for the fall 2022 intake in August or September
- The student has to have
  - a. a successful status of admission in NET24Apply platform,
  - b. receive positive decision about granting visa
  - c. make a payment required by WWSB
  - d. come to Poland for the studies and sign final agreement with WWSB on site
- Students registered after September 30<sup>th</sup>, 2022 will not be taken into consideration as a registration that authorizes for additional admission bonus and discount for the first year of studies from WWSB

Terms:

#### Bonus for admitted students

- The amount of additional admission bonus will be paid depending on **the date of registration of the student** in Admission section on NET24Apply platform.
- The admission are considered for the **closest intake: Fall 2022**
- **The rate of the admission** bonus is as follows:
  - **For students registered in August: 200EUR** per each candidate that will successfully start the studies in WWSB in fall 2022 intake
  - **For students registered in September: 100EUR** per each candidate that will successfully start the studies in WWSB in fall 2022 intake
- The payment terms is stated and controlled by the **Warsaw University of Business (WWSB)**, without interference of NET24.

#### Discount for first year of studies

- The amount of the **discount for the students registered for the first year of studies** is 500 EUR.

- The eligibility for discount for the first year of studies will depend on **the date of registration of the student** in Admission section on NET24Apply platform.
- The discount applies only for the students registered in **August and September 2022**
- The discount will be deducted from the **total annual tuition fee for the first year of studies**
- The discount applies to **all the programs** offered by WWSB

### **3. Agreement to Rules**

Registering the student in NET24Apply platform to WWSB and applying for the additional admission bonus is tantamount with agreeing to the ‘Bonus policy & Regulations’ specified in this document.

Not meeting the terms&conditions will result in rejection of granting the **additional admission bonus and the discount for tuition fee in the first year of studies**

### **4. Disputes**

NET24 shares the platform for lead generation process. All the information regarding the bonus, discounts, terms and conditions should be directed to Warsaw University of Business. NET24 takes no part in signing the contract between students recruitment agency and the educator.

Any disputes that may arise between the Parties in connection with the performance of this Agreement shall, pursuant to Article 34 and Article 46 § 1 of the Code of Civil Procedure, be submitted by the Parties to the District Court for Warsaw-Śródmieście in Warsaw [Sąd Rejonowy dla Warszawy-Śródmieścia w Warszawie] as the court of the first instance.<sup>13</sup>.
